Description:

This land and timber offering is located north of Highway 57, along the east bank of the Hatchie River near Pocahton, TN. It is approximately 1,064+/- acres containing a diverse mixture of bottomland hardwoods, upland hardwoods, upland mixed hardwood-pine, and upland loblolly pine plantations. The property has road frontage along Highway 57 and Vernie Kirk Road. It is bisected by Mosses Creek with approximately 509+/- acres located north of the creek, and 555+/- acres located south of the creek.

Included within this bid package is a timber inventory conducted by Tennessee Timber Consultants. This inventory is being provided solely as a courtesy to prospective buyers. Neither the sellers, nor Tutt Land Co. guarantee the accuracy of this information. Prospective buyers should conduct their own evaluation of the timber.

GIS data is available upon request.

Access:

Any prospective buyer will have permission to enter the property for evaluation purposes. However, all prospective buyers, or representative of the buyer, must contact Tutt Land Company prior to accessing the property. A small parking area is located on the north side of Highway 57. From here, the property can be accessed by ATV or by foot.

Additional access (for viewing purposes only), is located along Vernie Kirk Rd (Pink Flagging Tape), utilizing a logging road that crosses the Eubank property (See Attached Maps). Parking will be limited to the area closest to the road. From here, the property can be accessed by ATV.



Method of Sale:

The following volume estimates were provided by Tennessee Timber Consultants, LLC. Timber volume estimates are presented in boardfeet (bf) using the Doyle Tree Scale. Form Class 78 was applied to all species, except Form Class 80 was applied to pine and poplar. Pulpwood volumes are presented in tons. A conversion factor of 8 tons per thousand boardfeet for hardwood and 7.5 tons/mbf for pine was used to estimate the amount of sawtimber tonnage.
